Medina County Fair Campers,

It is that time of year again. The 2025 fair dates are July 28 - August 3, 2025.

Enclosed is an application for this year's camping. Forms and payment are due back to the Fair Office by April 15, 2025. This deadline will be <u>enforced</u> due to the demand of campsites, if we do not have your paperwork fully completed with payment by <u>April 15, 2025</u> (if mailed, the envelope must be postmarked by <u>April 15, 2025</u>) you will lose your spot, and it will be opened for a new camper. If you wish to change to a different location, you must request it in writing along with the application and fee to the Fair Office. Starting May 1, 2025, campsites will open to brand new campers who are on the waiting list.

Camping fees have gone up this year: North camping lot - \$300 & South/Concessions camping lot - \$325.

All applications NOT FILLED OUT COMPLETELY, will be sent back to you with your payment. We must know the correct size (from hitch to bumper/spare tire) and type of unit you plan to camp with to give you adequate room. The campgrounds will be open at 9:00 A.M. Friday, July 25 and are then open thereafter, unless prior arrangements have been made with the Chairman/Asst. Chairman. Your permit will be ready for pick up on July 18, you must have the permit on your camper, if it is not picked up and, on the camper, you will run the risk of your camper being removed. Sincerely,

RULES:

- 1. No dog or pets permitted in or on the GROUNDS during the week of fair.
- 2. Space fees do not include fair entry. Everyone staying in campers must have and hold a ticket for the week of the fair. Tickets must be Membership ticket, Season ticket, Mini ticket, Jr. Fair punch pass or Jr. Fair advisor ticket. Gate #6 to enter the Fairgrounds by the campgrounds is a PASS ONLY gate.
- 3. You must be age 18 or older to reserve a campsite in your name.
- 4. Adult supervision is required for those under 18 at each campsite. We will enforce an 11:00 P.M. curfew.
- 5. Campsites cannot be subleased. The MCAS has the right to terminate any contract at any time if you are caught subleasing.
- 6. Campsites must be kept in an orderly condition. No alcoholic beverages or illegal drugs are permitted in the campgrounds.
- 7. Health and fire codes must be respected and observed. This includes NO OPEN FIRES.
- 8. No waste of any type is to be dumped at any time in campgrounds. A dump station and waste disposal service are available to pump sewage tanks. All campers must have a container for grey water. Any signs of dumping in campgrounds will mean removal of camper and permit.
- 9. Camping permits must be displayed in a place visible from the roadway.
- 10. NO VEHICLES ARE TO BE PARKED IN THE CAMPGROUND AREA.
- 11. <u>NO UNATTENDED VEHICLES IN THE CAMPGROUND AREA DURING THE WEEKEND OF DROP OFF FOR</u> <u>CAMPERS.</u>
- 12. Electric to the campsites will NOT be turned on until Friday, July 25, 2025. Electric will be turned OFF the evening of Monday, August 4, 2025.
- Any camping unit that exceeds the following must use the South campgrounds or appropriate designed camp spots:

 Pulls over 30 amps of electricity (<u>MAKE SURE YOU HAVE THE PROPER 30-50 AMP ADAPTER HOOK UP!</u>)
 Has more than one air conditioner
- 14. Campgrounds are for recreational units only. Horse trailers must comply with County Health Dept. rules. No concession storage trailers allowed.
- 15. No outdoor electrical appliances including refrigerators & freezers.
- 16. Persons not abiding by the rules will have their contract canceled and will be removed from the camping area with no refund.
- 17. The Medina County Agricultural Society reserves the right to cancel a site contract at any time or refuse or reject any application.
- 18. The Medina County Agricultural Society will not be responsible for any accidents of any sort.
