In consideration of being permitted to compete or participate in anyway in the Medina County Fair Autocross (“the Event”), I, for myself, my personal representative, heirs and next of kin:

1. Acknowledge, agree, and represent that I do not have any physical under medical conditions which would prevent me from participating in the event or otherwise performing any duties related to the Event. This Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement includes the Medina County Fair, its Board of Directors, agents, owners, officers, affiliates, successors, assigns, volunteers, fellow participants, drivers, rescue personnel and any other persons on the premises (“Releasees”) for purposes of the Event.
2. I hereby release, waive and discharge from all liability and covenant not to sue Releasees for any and all loss or damage, any claim or demands on account of injury to may person or property or resulting in my death arising out of or related to this Event, whether caused by the negligence of Releasees or otherwise.
3. I hereby agree to indemnify, save and hold harmless Releasees from any loss liability damage or costs that may have incurred arising out of or related to my injury, death and/or participation in the Event, whether caused by the negligence or Releasees or otherwise.
4. I acknowledge the activities of this Event are very dangerous and may involve the rise of serious injury and/or death and/or property damage. Risk includes but are not limited to vehicle collisions, impacts with vehicles, entrapment in vehicles, fires, and/or explosions. I recognize the event may be held on uneven ground in differing weather conditions, making trips, slips and falls inherent in traversing these conditions. I expressly acknowledge any injuries maybe compounded or increased by negligent rescue operations or procedures of the Releasees.
5. This Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the Releasees including rescue operations and it is intended to be as broad and as inclusive as permitted by the law of the State of Ohio. If any portion is held invalid, the balance of this Release shall continue in full force and effect.

I have read this Release and Waiver of Liability, Assumption of Rise and Indemnity Agreement, understand its terms and understand I have given up substantial rights by submitting it. I execute this document freely and voluntarily without any inducement, assurance, or guarantee.
